PORTOLA CITY COUNCIL SPECIAL MEETING MAY 2, 2012 4:30 P.M.

CALL TO ORDER

Mayor Mark called the meeting to order at 4:30 p.m.

ROLL CALL

Councilmember Weaver, Mayor Pro Tem Larrieu and Mayor Mark responded to the roll call. Councilmembers McBride and Oels were absent. City Manager Leslie Tigan, Finance Officer Susan Scarlett and Public Works Manager Todd Roberts were also in attendance.

PUBLIC COMMENT

There were no comments from the public.

Councilmember McBride arrived at the meeting at 4:31 p.m. Councilmember Oels arrived at the meeting at 4:49 p.m.

ORDER OF BUSINESS

A. <u>2012/2013 Operating Budget</u>

City Manager Leslie Tigan and Finance Officer Susan Scarlett presented a preliminary 2012/2013 budget to the City Council. They explained that during the meeting the City Council would go over the budget and make suggestions for changes if necessary. The Council will also review the list of add-on items and take action to include those items in the budget.

City Council and staff reviewed the projected revenues and expenditures in each fund and discussed various issues including the projected expense of the Landfill closure project and projections for Fire Department expenses if some type of Joint Powers arrangement could be finalized with the Beckwourth Fire Department. Staff reported that the budget presented showed the lowest possible expenses necessary to provide the current level of City services.

After reviewing the list of proposed add-ons to the budget the City Council took the following actions:

Ms. Scarlett noted that merit step increases for the three employees eligible for the steps were included in the budget presented to the City Council. Mayor Mark suggested that the employees could be asked if they would be willing to voluntary forego their steps as they had two years ago.

Councilmember McBride and Mayor Pro Tem Larrieu indicated that they did not feel the expense of the steps had much of an impact on the budget and felt the employees were deserving. It was the consensus of the Council to have the employees meet with the Finance & Administration Committee and then the Committee could bring a recommendation back to the City Council.

Ms. Scarlett presented budget worksheets that showed the comparison of a budget with water and sewer rates remaining constant to projections that included a rate increase as outlined in the rate study. Mayor Mark indicated that the Rebuilding Portola group would be making a presentation to the City Council next week and felt their report may include information that would assist the City Council in making a decision on rates. It was the consensus of the City Council to await the report and hold another work session for the discussion of rates.

ADJOURNMENT

There being no further business to discuss it was moved by Mayor Pro Tem Larrieu, seconded by Councilmember McBride to adjourn the meeting at 7:10 p.m. All members present voted in favor.
